Media Inquiry Policy

PURPOSE

To establish policy regarding communications between members of the media and employees of the Indiana Department of Workforce Development (DWD) and Indiana's workforce investment system personnel.

RESCISSION

DWD Policy 2008-03 dated August 5, 2008 and entitled, "Media Inquiry Policy"

CONTENT

From time to time employees of the Department of Workforce Development or employees in Indiana's workforce investment system will have the opportunity to interact with news reporters and media outlets. In our efforts to strengthen ties among workers, businesses, learning institutions and the unemployed, it is essential to have a coordinated message that accurately reflects the mission and the goals of our agencies. The Indiana Department of Workforce Development's Communications Division brings a myriad of tools and skills to handle and manage issues related to developing public relations strategies. As the Department's voice and vision must be clear, the Deputy Commissioner of Communications ensures that all aspects of agency communications are covered to ensure our message has been delivered successfully. Guidance concerning media inquiries is provided:

Department of Workforce Development staff

The Department of Workforce Development's Deputy Commissioner of Communications is the lead authority for all agency communication including media inquiries. All media inquiries shall be immediately referred to the Deputy Commissioner of Communications. Media inquiries

include, but are not limited to, telephone calls, e-mail inquiries, and videotaping and in-person interview requests made by members of the media.

Only employees within the Indiana Department of Workforce Development Communications Division are permitted to contact members of the media without prior authorization from the Deputy Commissioner of Communications. "Contacting the media" means: communicating with members of the media by any means, including, but not limited to making statements, sharing information or conducting interviews. All press releases and other materials distributed to the media must receive prior approval from the Deputy Commissioner of Communications as well.

Upon receiving a media inquiry, DWD employees must contact the Deputy Commissioner of Communications directly via telephone at 317.233.1463. Any violation of the Media Policy will be grounds for disciplinary action.

Indiana's workforce investment system personnel

All Indiana workforce investment system personnel who receive a media inquiry should immediately notify the Deputy Commissioner of Communications. The Deputy Commissioner of Communications will work cooperatively with Indiana workforce investment system personnel in coordinating the appropriate response.
