

Dear Mr. Miller:

This letter constitutes notice under the Federal Worker Adjustment and Retraining Notification Act ("WARN"), 29 U.S.C. §2102 et seq., and related Department of Labor Regulations, that there will be a "mass layoff" or "plant closing", as defined by WARN, at the Macy's Lafayette Square store located at 3919 Lafayette Rd., Indianapolis, IN 46254. Job eliminations are expected to be permanent, and are scheduled to occur between March 13, 2009 and March 26, 2009.

Enclosed is the list of job titles of positions expected to be affected at this time, the number of affected employees in each job classification and the dates these employees are expected to be separated. The affected employees do not have "bumping rights" and are not represented by any labor organization or other representative. Each employee will be given a description of their benefits and will be considered for other available job opportunities within the company.
