


PETITION FOR APPROVAL OF RATE AND CHARGE DIFFERENCE
BETWEEN PROPERTY WITHIN AND PROPERTY OUTSIDE THE
CORPORATE BOUNDARIES OF THE TOWN OF MONROE CITY.

Pursuant to Indiana Code 8-1.5-3-8.3(c), Town of Monroe City, by counsel, requests the Director of the Water and Wastewater Division of the Indiana Utility Regulatory Commission ("Commission") to approve the rate and charge difference between property within and property outside the corporate boundaries of Town of Monroe City ("Municipality"). In support of its request Town of Monroe City states:

1. The ordinance setting rates and charges for property within and property outside the municipality's corporate boundaries took effect on February 7, 2001, for the municipal water utility.
2. Attached as "Exhibit A" is a copy of the Ordinance.
3. The work that is the subject of the Ordinance is:
 - a. water utility works X
 - b. wastewater utility works
 - c. both water and wastewater utility works
4. The percentage difference between then rates and charges imposed on users of the works for service to property located outside the corporate boundaries of the municipality and to property located within the corporate boundaries is 23.5%
5. If the percentage difference in #4 above varies based upon the amount of consumption, please provide a chart illustrating the various consumption level is 1000 gallon increments with the corresponding percent surcharge and attach to this Petition.
6. Michael Edwards is counsel of record for Petitioners in this matter and is duly authorized to accept service of papers in this cause of behalf of Petitioners.

WHEREFORE the Town of Monroe City, Indiana, requests that the Commission issue an Order approving the percentage rate and charge difference between property within and property outside the corporate boundaries of Town of Monroe City, Indiana, and for other just and reasonable relief.

ORDINANCE NO. 2-01

An Ordinance establishing a schedule of rates and charges to be collected by the Town of Monroe City from the owners of property served by the water works of said Town.

WHEREAS, the Town Council of the Town of Monroe City is aware of the need for improvements to its existing water works system, and

WHEREAS, the existing rates are inadequate to provide cash flow to meet current expenses and to provide for appropriate reserves for improvements and modifications to such system, and

NOW, THEREFORE, be it ordained that the rates effective upon passage of this Ordinance shall be changed as follows:

First 2,500 gallons	\$2.74
Next 7,500 gallons	\$1.68
Next 10,000 gallons	\$1.47
Next 30,000 gallons	\$1.27
