The Indiana Utility Regulatory Commission (the "Commission" or "IURC"), pursuant to IC 8-1-1-3(g) and 4-22-2.5-2, hereby readopts 170 IAC 6-1.1-1 through 170 IAC 6-1.1-8 regarding distribution system improvement charges.

A notice of intent was published on July 13, 2011 in the Indiana Register. No requests for any part of this readoption to be separate from this action were submitted in writing within 30 days of this publication. On August 24, 2011, at 2:00 p.m. EDT in the IURC Conference Center Suite 220, PNC Center, Indianapolis, Indiana, a majority of the members of the Commission were present and adopted the foregoing rule.


The Commission's General Counsel shall forward copies of the attached rule to the Indiana Legislative Services Agency for publication in the Indiana Register.



### DIGEST

Readopts rules in anticipation of IC 4-22-2.5-2, providing that an administrative rule adopted under IC 4-22-2 expires January 1 of the seventh year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the Publisher.
